PART A: Acceptance of the Statute and Internal Regulations & Release of Liability

- 1. Acceptance of Statute and Regulations:** The undersigned declares to have fully reviewed and to accept without reservation the Statute and the Internal Regulations of the Intellivita ETS Association, recognizing their full validity and binding nature. They undertake to observe their provisions, contribute to the pursuit of the Association's aims, and maintain conduct consistent with the principles and values of the Association.
- 2. - 3. Observance of Directives and Individual Responsibility:** The undersigned undertakes to scrupulously follow the instructions, directives, and recommendations given by the instructors, teachers, managers, and volunteers of the Association during the performance of all activities. They acknowledge that responsibility for their own safety and well-being, as well as for any damages caused to third parties or to the property of others due to negligence, imprudence, or violation of rules, lies exclusively with the undersigned.

4. **Release of Liability:** The undersigned releases the **Intellivita ETS Association, its Corporate Bodies (including Administrative Body, President, Board Members), members, volunteers, instructors, teachers, and all collaborators, from any civil and criminal liability** for any damages, injuries, illnesses, or detrimental consequences (direct or indirect, material or immaterial) that may arise to their person or to third parties, or to their property, as a result of participation in the Association's activities.
